#### President's Report

The recent Annual Meeting was held Sunday, August 19th, and three new Board members were elected/re-elected to threeyear terms. They each bring a variety of experiences and perspectives to the Board that will enable them to continue the good work of departing Board members Valerie Barker and Frits Rizor.

Former Board President Greg Ptacin has agreed to spend the last year of his six years on the Board serving as the Vice President to ease the transition as he steps down from the presidency. Eric Lapp and Tom Mathews will continue their excellent work as Secretary and Treasurer, respectively. Members continuing in their current Board roles include Linda Lonsinger, Dwain Mickey, Dave Miller, and Jim Lloyd (exofficio).

I hope you will express your appreciation to these fine individuals when you see them for either their past and/or future volunteer service.

With this talented group of people, I am confident that we will continue to advance the positive momentum generated by the previous Board. Please know that our Board depends on your support and involvement to be successful.

An unfortunate result of the Annual Meeting is that the proposed assessment increase was narrowly defeated. It is disappointing that only 549 votes out of

a possible 1504 were cast. For future consideration, if you are unable to vote in person, please be sure that you sign up for an Absentee Ballot. It is really important that every member vote.

With regard to the proposed assessment, the increase was going to help pay for costs that are increasing beyond the CPI index which triggers annual assessment adjustments per our Code of Regulations.

As a result of this defeat, the Board and the Management Committee will spend the next few months analyzing the budget situation further and communicating with members to determine if our priorities need to change or what our next steps will be.

I encourage you to share your thoughts and opinions with Board and Management Committee members as we determine the next steps.

On a lighter note, September is right around the corner and autumn will soon follow. On behalf of the entire Board. I hope this has been a fun-filled summer for you. Don't miss the exciting Labor Day activities in the Hills!

#### Paniccia Properties

Long time HAH resident's Frank and Sandy Paniccia have given HAH several properties. Tax considerations precluded a donation, so it was done as a sale for \$1. Included were 12 HAH lots, the former Paniccia real estate office and the lot and house next to the Kessler swamp.

Paniccia acquired 60 lots in 1993 with an agreement to market them to prospective buyers. In exchange for the marketing efforts, the lots were assessment free. That means HAH did not lose any assessments when taking back the lots. Forty eight lots were sold, giving HAH monthly assessments. General Manager Randy Swetnam says two of the lots we got back are very buildable. When we sell them, it will more than offset any added expense from taking the lots and real estate office back.

The Health and Wellness Committee has been renovating the office for an exercise facility with Frank's permission. H & W is working on a proposal to bring the office up to a suitable state through donations of those members in support of the exercise facility project and not add any significant expense to HAH.

#### PONTOON BOAT REMOVAL/STORAGE FORM OCTOBER 27, 2018

Each fall, the HAH Lakes Committee removes the pontoon boats at the Club docks and private docks on the Lake of the Four Seasons. The two (2) options for removal are listed below:

Option #1 – Cost is \$95.00 - The committee will remove the boat from the lake on the above date, store it near the dam, at the old baseball field site for the winter and launch the boat in the spring, provided the boat is properly registered with the Club Office.

Option #2 – Cost is \$65.00 – You remove your own boat from the lake before or after the above date, store it near the dam, at the old baseball field site for the winter, and you launch the boat in the spring. DO NOT store in paved area.

The form below must be completed, signed and received in the Club Office with payment by October 17th.

Pay with a SEPARATE CHECK payable to HAH Club.

#### Please keep in mind:

Make sure your current lot number is the ONLY lot number on your boat.

Make sure your private dock is numbered with your lot number, to match your boat.

Please choose another time (other than the day of removal) to remove your boat if you are not involved in the removal with the Committee.

NO SPECIAL REQUESTS/REQUIREMENTS WILL BE ACCEPTED - example: boat will need to be accessible for repairs during the winter. In this case, you should choose Option #2 and place boat there after October 21.

Motors must be in the up position or we will not remove your boat and it will be your responsibility to remove your boat and store it on the dam and leave the motor up.

VOLUNTEERS are needed for on-boat crews, docks and parking lot.

Volunteers should meet at the dam at 7:30 a.m. for coffee, donuts & job assignments. Launch starts at 8 a.m. Call Sue Pyle at 740-569-6209 to volunteer.

#### HIDE-A-WAY HILLS CLUB ORV RULES AS OF 3/25/17

#### **VEHICLES**

- 14. Notwithstanding the above numbered Vehicle Rules, and the Off Road Vehicle Rules that apply to the designated ORV track and trails, the following shall apply to all Off-Road-Vehicle (ORV) operators under the age of 16 when using Hide-A-Way Hills roadways. "ORV" shall include, but not necessarily be limited to any ATV, Utility Vehicle, Side-By-Side, Go-Kart, Dirt Bike or Golf Cart. It shall not include cars, vans, trucks and SUV's.
  - A. All ORV operators under the age of 16 and their parent(s) must attend a HAH ORV Rules Meeting sponsored by the ORV Committee.
  - B. No ORV may be operated by a person under the age of 12 without a parent or responsible adult present.
  - C. Such ORV operators must understand and comply with the vehicle manufacturer's recommendations for safe operation and ensure that the maximum number of passengers does not exceed the number of seats in the vehicle.
  - D. In addition, helmets must be worn by all such operators and riders of an ATV, Go-Kart or Dirt Bike. Seat Belts must be worn by all such operators and riders in vehicles where they are supplied. Go-Karts and other low-profile ORVs less than 4 feet from the ground must display a flag extending vertically at least 4 feet.
  - E. The parents of all under-age ORV operators must read and sign the "Parental Consent and Release" form acknowledging the inherent risk associated with operating an ORV, and attesting that they and their child understand and will comply with all HAH rules.
  - F. Upon confirmed attendance at an aforementioned ORV Committee sponsored meeting, and completion of the "Parental Consent and Release" form, a sticker will be issued for display on any ORV to be used by an underage operator. No ORV shall be operated by an underage driver on HAH roadways without such a sticker clearly displayed. Violations of these rules are subject to the Schedule of Fines section of the Hide-A-Way Hills Club Rules.

#### OFF-ROAD VEHICLE (ORV) RULES

The following rules cover use of the Hide-A-Way Hills ORV track and trail area. All existing Hide-A-Way Hills Club rules also apply.

- 1. The use of the ORV track and trail area is restricted to Hide-A-Way Hills members and guests on member owned ORVs. Social guests must be accompanied by the member.
- 2. Please enter the ORV track from the posted entrance point.
- 3. The ORV track is one-way only—counterclockwise. Do NOT go clockwise or cut the track.
- 4. When riding the trails through the woods, do not cross the signs marking the shooting range.
- 5. The ORV Committee strongly recommends that a certified helmet be worn by all riders.
- 6. The ORV Committee strongly recommends that participants riding in side-by-side UTV's fasten their seat belts.
- 7. Due to the possibility of an accident requiring a call for medical assistance or other help, the ORV Committee strongly recommends that riders not be alone on the track or trails.
- 8. Riders are prohibited from using the ORV track or trail area while impaired by the use of alcohol or drugs.
- 9. Ride at your own risk, and take care to not exceed your ability to control your vehicle.

The ORV Committee strongly recommends that riders 12 and under be accompanied by a parent or adult. The parent or adult should be at the track but does not have to ride.



- We have two new members of the Board of Trustees who are present this evening, Scott Martin and Dennis Aubrey. We welcome them both. We have two members who are no longer with the Board, who attended their last meeting on Sunday; they are Frits Rizor and Valerie Barker, who both served us extremely well. Valerie indicated that she would still like to be involved with the Delinquency Panel and I gratefully accepted her offer.
- I am pleased to announce the officers, Greg Ptacin and I have switched seats, Greg has agreed to help me out and this will be his last year on the Board, so Greg is now in the Vice President role, Eric Lapp will continue on with the Secretary role and Tom Mathews will continue as the Treasurer.
- We did have one very disappointing event at Sunday's Annual Meeting; the assessment increase did not pass. We are going to talk about that later. We did not get enough people out there to vote, we were just short of enough votes for passage.
- One more thought, it is August 21<sup>st</sup> and that means summer is almost over. It has been a great and safe summer. When we
  meet in another month, summer will be over.

#### TREASURER'S REPORT - Tom Mathews

Total committee funds in the Vinton County National Bank on July 31, 2018 were \$116,514.18. Motion to approve made by Tom Mathews; second by Scott Martin – **Motion Carried** 

#### MANAGEMENT COMMITTEE REPORT – Jim Kirk

- We had the guard shack tested for mold and there was none found in the building. As everyone knows that building sits in a low spot that tends to stay very wet, so that is good news. We were concerned that there may be mold underneath.
- After using sales information broken down by the hour, we are changing the Lodge's hours. Tuesday, Wednesday and Thursday will be 5pm to 10pm, Friday and Saturday will be 5pm to 11pm. The only change there is Friday and Saturday was reduced from 12:00 to 11:00 pm. We thought there may be a bump at midnight with people cashing out but sales from 11 to 12 were minimal.
- We are doing an improved chip and seal process this year. The improved process includes sweeping the road of gravel and debris first so that the tar has a better chance of sticking. Repairs, when possible, have been done with hot patch, instead of limestone which washes out too easily. Due to the shortage of funds, this process will not be used on all of the chip and seal areas. We made the decision that if we were going to get everything done this year, we were going to have to go with the less expensive method of using 4/11 limestone.
- We had an issue brought to us on docks lost due to delinquency, so we have made some changes. The Dam assessment did not have a 30 day past due letter going out, so we are now sending out the 30 day letter for the Dam assessment. Another change is we are running a 55 day delinquent report and making a courtesy call to the member. Another issue with the docks is that you would lose your dock if you do not have a boat in the dock for three weeks in a row and you have not notified the office that you have your boat out for repair. We now have Security checking more often and focusing on empty docks.
- The Clubhouse had a really good month in July turning a profit of \$4,600 on an increase in sales of over \$7,600. The Lodge had a slight improvement in profitability and sales.
- We now have an opening in the Hide-A-Way Hills Office and will be advertising for help wanted immediately.

#### GENERAL MANAGER'S REPORT – Randy Swetnam

Delinquency Assessments: July 15, 2018: \$15,160.00; August 15, 2018: \$16,494.00 Delinquency Roads: July 15, 2018: \$0.00; August 15, 2018: \$4,400.00 Dam Assessment Bank Account Total as of August 17, 2018 \$397,142

• I want to let everyone know that the fall OLCA meeting is going to be held at Lake Waynoka this year, which is just southwest of Hillsboro and east of Cincinnati. It will be September 19 and 20, 2018. Board of Trustees, Management and Committee Chairs entry fee is paid by the Club if anyone would like to attend. I would encourage you to attend at least one of the day's sessions, because they are very interesting and informative.

- I sent out a lakefront property cleanup E-blast and am getting good responses on that. I have had several people call me and
  apologize and have had people call and say it is about time you did this. I apologize for not getting this out sooner, but am getting responses.
- The Hocking County Health Department has come in and done mosquito testing on the Hocking County side and found one positive test for West Nile Virus. I have called Fairfield County and I am meeting with them tomorrow morning to set some traps on the Fairfield County side. We will probably set one in the North Park area, in the North Dock area and will probably set one over in Area 54.
- Jim Kirk and I met with South Central Power. They are going to start their five year right-of-way clearing right after Labor Day. We had some issues with them leaving debris in members' yards, so we had a discussion with them about that. Anything that they cut on a member's property will be chipped and hauled away.

#### **COMMITTEE BUSINESS AND FUNDS REQUESTS**

No consolidated committee reports were submitted.

We will no longer print paper copies of consolidated Committee Report - only email to Board.

<u>FFF Committee</u>: Deck update – We are still working hard to find a contractor. We have talked at length with 3 contractors, and have given our plans now to a total of 6 contractors. One partial bid has come back but did not meet our specifications. Pat Lynch is also working with us to try to find a contractor. We would like to get this started as soon as possible. The fund raising has gone well and I spoke with Kathy Clevenger earlier, who has been leading the fund raising efforts. We both think that with all the pledges and the money on hand, we have over \$70,000 for the project.

<u>Barn Committee</u>: Fence line clearing amenity project has been completed. There are still problems with the downspout which is causing flooding in the stalls, and a roof leak in the hay storage area. A gate post needs to be reset in field 2, as well as installing a new gate. There are two upcoming fundraisers, the annual Boo at the Barn and the new pumpkin sale fundraiser which will be in October.

#### Airport Committee:

- The Chicken Dinner sale is going quite well, I believe there are less than 40 left out of the original 100. Lanette Kilbarger and I have been up at the Clubhouse in the evenings and we are selling the 60/40 tickets and the chicken dinners to be delivered on the lake on September 2<sup>nd</sup>.

Range Committee: Amenities funds have been used to install a ceiling inside range with new lights and we flipped the doors. We have a trap shoot scheduled for September 15<sup>th</sup> and we will supply the shells and even shotguns if needed. We will have a 50/50 raffle and a cookout. This will be a good time to come see the Range.

<u>Social Committee</u>: This Saturday from 11am-1pm, the social committee will be selling license plate covers at the front gate. Popgun will be playing September 1<sup>st</sup>. Grilling competition was a great success this year.

<u>Architectural Control Committee</u>: ACC met and made some changes to temporary permits. We have not required members to obtain permits for repairs such as damage from a fallen tree. There will be a green permit posted to let everyone know that the member has applied for a permit. This will be a no charge permit for temporary outside structural repairs.
