Load limits will begin on February 1 and continue through April 15, 2019. Please plan your construction and/or moving plans accordingly.

General Rule #25

"Load limits will be placed on all roads during inclement weather to prevent damage to the roads. No vehicles in excess of five (5) ton gross weight, will be permitted during such enforcement, except emergency vehicles or any vehicle approved by the General Manager. Penalty for violation of the load limits will be a \$500.00 fine to the member, per occurrence."



Snow Season in HAH

Members, please remember to remove all vehicles and/or any obstructions from our roadways on snowy days which could hinder our Maintenance Department from clearing the roads for us.

Not only will it keep our employees safe, but will also ensure no damage will be done to your vehicles/personal property.

The HAH right-of-way is defined as 20' from the center of the road.

President's Report

By now, most members are aware that a burglary attempt was made at a member's property by an individual long associated with HAH. Fortunately, the property was equipped with security cameras and an alarm system, and the member was able to alert HAH Security and the Hocking County Sheriff quickly. As a result, the individual was apprehended, arrested, and charged with three crimes. I want to applaud the efforts of our security team and to extend appreciation to the Hocking County Sheriff's office for their quick and successful responses.

This event heightens the importance of efforts already underway to pursue a more comprehensive approach to community security as described in my November message. The Board is aware that while the number of property crimes in HAH is small, they are increasing. As a result, we have been working with the Sheriff and the club's attorney to identify additional preventive measures that might be taken.

You may also recall that the Management Committee is investigating gate-access security options and will be evaluating those options soon. An important aspect to keep in mind is that when we consider additional measures and improvements, we must also identify new sources of income to fund them.

The Board will continue to work deliberately on this important community issue. If you have suggestions for actions that

should be taken, please be sure to share them with one of the Board members or Management Committee members. All contact information is available on the Club's website under the Member's Info tab. In the meantime, members are encouraged to report any suspicious activity to HAH Security.

On a much brighter note, it's that giving time of year! HAH has a long tradition of showing our collective appreciation to our valuable staff by collecting contributions for annual holiday gifts. Although we are a community of volunteers, we are reliant on our staff; they maintain our roads and facilities, provide security, assistance and information, oversee and manage Club operations, and prepare and serve the fine food and drinks at the Clubhouse and Lodge. Without these individuals, Hide-A-Way Hills would not be the outstanding community it is. 





We are all aware there has been a troublesome event in the Hills. Last weekend there was an attempt to burglarize a Member property by an individual who has been long associated with HAH. Fortunately, the member property was equipped with security cameras and an alarm. The Member was able to quickly alert our HAH Security and the Hocking County Sheriff and the individual was apprehended and arrested. We are appreciative that the quick response was successful and the crime minimized.

The Board is aware that there have been a small but increasing number of property crimes in the Hills. We are working with the Sheriff and our attorney to pursue additional preventive measures. The Management Committee is also investigating gate access security options and we expect to evaluate options shortly. There will be costs associated with this improvement that we will share with everyone.


